A. Call to Order

Ms. Vanderslice called the meeting to order at 9:04 pm

- D. Discussion and/or Action
 - 1. Paving Update and Funding Request Assistant Director/Town Engineer Frank Smeriglio noted year-to-date 15.5 miles have been paved. 2.4 miles remain to be paved. Mr. Burney noted that with changes that have been put in place and Mr. Smeriglio's leadership, more miles were paved than ever before. Mr. Burney reviewed the process for contracting a paving contractor for the next year and the need to have a commitment in place before beginning the new paving year. Ms. Vanderslice noted without an Annual Town Meeting in 2020, bonded monies were not approved for next year. Savings in the FY2020 operating budget can allow paving to continue into early next year, but Mr. Smeriglio stated an additional \$320,000 would be needed to continue paving through

the next Annual Town Meeting in May 2021. Discussion amongst the members on

Ms. McFadden congratulated Mr. Smeriglio and Mr. Burney on continuing the high level of mileage paved during a very difficult year. Mr. Smeriglio noted that Pat Cavalieri was promoted to Highway Supervisor following Bob Fleming's retirement and was doing a very good job in that position.

2. Center for Tech & Civic Life Election Grant – Anne Kelly-Lenz Ms. Vanderslice and Ms. Kelly-Lenz reviewed the Center for Tech & Civic Life Election grant totaling \$6,112.50. After review and discussion, motion moved by Ms. Bufano to accept the grant seconded by Ms. McFadden and carried 5-0.

Ms. Vanderslice reviewed correspondence Farm Manager Drew Duckworth of Millstone Farm asking to reopen discussions about a new trail on the property. Ms. Vanderslice reviewed with the board the past history. After input from the board, Ms. Vanderslice noted that a lot of time and expense have been spent on this issue and there was not interest in reopening discussions unless the issues that were previously identified had been addressed. She will report back to the Town Environmental Director Mike Conklin on the board's discussion.
