BOARD OF SELECTMEN REGULAR MEETING Tuesday March 22, 2022 Held Electronically

- A. Call to Order

Ms. Vanderslice called the meeting to order at 7:00pm.

Ms. Vanderslice asked for a motion to add an item to the agenda: Possible Appointment to the Conservation Commission as item E-8. Motion moved by Mr. Nabulsi and seconded my Mr. Cole. Correction to motion noting only 6 items currently on agenda. Motion to add an item to the agenda: Possible Appointment to the Conservation Commission as item E-7. Motion moved by Mr. Tartell, seconded by Mr. Cole and carried 5-0.

- B. Public Comment None.
- C. Executive Session

Interview – David Silvia (Conservation Commission) Motion to go into Executive at 7:04pm for Interview with David Silvia for the Conservation Commission. Motion moved by Ms. Healy, seconded by Mr. Tartell and carried 5-0.

Out of Executive Session and back in Regular Session at 7:39pm.

D. Consent Agenda

Motion made by Mr. Cole seconded by Ms. Healy and carried 5-0 to approve the Consent Agenda as follows:

- E. Discussion and/or Action
 - Wilton Train Station Pedestrian Bridge Authorization to Bid Frank Smeriglio Frank Smeriglio noted Town received authorization to go out to bid for the Wilton Train Station Pedestrian Bridge that would connect the train station parking lot to the Merwin Meadows. He reviewed next steps in the process and how the grant that was received for this project works. Discussion amongst the board. Follow-up to occur to confirm with Planning and Zoning on design.
 - 2. Update Police Headquarters Project

Ms. Vanderslice introduced Rebecca Hopkins and Jeff McElvray of Tecton who updated the board on the Police Headquarters Project. Ms. Hopkins updated the board on Probable Project Costs for the project for current market conditions (see attached). She noted the previous projected coast of \$16.7 million is now projected to be just over \$16.9 million. Discussion amongst the board.

- 3. ARPA Funding Request Town-Owned Buildings Chris Burney Item Tabled until the April 6th BOS meeting.
- 4. William Kenny & Associates Contract Schencks Island Ms. Vanderslice reviewed the William Kenny & Associates Contract for Schencks Island noting that the project was approved at a previous BOS meeting. Review process showed that the BOS only authorized the expenditure and First Selectwoman was intended to come back to BOS for approval to execute the contract. Contract was executed and work is in progress and wanted to bring to BOS to make aware. After discussion a motion was moved by Mr. Tartell to support the execution of the contract that has already occurred. Motion seconded by Mr. Cole and carried 5-0.
- 5. Vision Appraisal Assessment Related Contracts

Ms. Vanderslice reviewed the Vision Appraisal Assessment Related Contracts noting that Vision Appraisal currently supplies Computer Assisted Mass Appraisal (CAMA) software for the town. Bids were received and contracts reviewed by Town Counsel. Ms. Vanderslice noted using this software does not restrict the Town's ability to pick another vendor for the revaluation process. After discussion and review, motion moved by Mr. Tartell to authorize the First Selectwoman to execute the contracts and seconded by Ms. Healy. After further discussion, Ms. Vanderslice noted that dates in contracts will change and amended the motion subject to clarifying what appears to be inconsistencies under section 2.2 and in section 5 of the contract. Motion carried 5-0.

- Proposed Legislation Change in Assessment Method for Motor Vehicles Ms. Vanderslice reviewed the Proposed Legislation – Change in Assessment Method for Motor Vehicles with the board. When a car is purchased the assessment would be based on the manufacturers suggested pricing and then depreciated over 20 years from that pricing. Bill proposed has good support.
- Possible Appointment to the Conservation Commission Motion moved by Mr. Nabulsi, seconded by Mr. Healy to appoint David Silvia as a member of the Conservation Commission to fill the longest outstanding vacancy. Motion seconded by Ms. Healy and carried 5-0.
- F. Public Comment None.
- G. Selectmen's Reports
 - 1. First Selectman
 - Ms. Vanderslice gave an update on fuel costs noting she will be bringing the information to the BOF deliberations.

Ms. Vanderslice noted that an e-alert was sent out noting information on how to access budget data and how to provide comment - available on the town website.

She noted that an email was sent to the board in regard to House Bill 5167 that will allow Wilton and other specifically named municipalities to delay revaluation if so choose. Moved forward with joint support.

Public Hearings for BOE & BOS on FY23 budget will take place at Middlebrook School (in person) on March 23 (BOE) and March 24, 2022 (BOS) both at 7:00pm.

Ms. Vanderslice noted a meeting set to take place on Regional Firing Range on March 24, 2022 noting there is quite a bit of interest in the topic as well as a grant opportunity.
