E. Discussion and/or Action

- FFY 2022 State Homeland Security Grant MOA
 Chief Blanchfield reviewed the FFY 2022 State Homeland Security Grant MOA. After review, motion moved by Mr. Tartell seconded by Ms. Healy to authorize the execution of the FFY 2022 State Homeland Security Grant MOA. Motion carried 4-0.
- Contract 4th of July Fireworks Pyrotecnico Fireworks, Inc.
