- B. Discussion and/or Action
 - 1. Wilton Energy Management Plan

Mr. Bruce Hampson, Chairman of the Wilton Energy Commission, gave a presentation on the Town of Wilton Energy Management Program. He commended Bob Nerney and Mike Ahern on their contributions in reporting

requirements of the 2009 AARA Grant funds. OPM officials commented that Mr. Nerney did the best job in administration of all towns that received funds. Strategic Building Solutions is the firm that was commissioned to prepare Wilton's Energy Management Plan.

All Town facilities, including schools, energy costs for the year ending 12/11 totaled \$1.97MM. The Energy Commission has three goals:

- a) Reduce total energy consumption 5% per year (power and heating oil)
- b) Designate an Energy Champion in each Facility
- c) Designate an individual to input energy data into Program and distribute to each energy Champion for posting and to show progress.

A copy of the Goals and Policy Recommendations of the Energy Commission is attached.

Mr. Brennan moved to adopt the three goals of the Wilton Energy Commission as outlined. Motion seconded and unanimously carried.

2. Economic Development Commission

Mr. Dubow drafted a Vision, Mission, Objectives, Duties and Responsibilities for a Wilton EDC. The other Selectmen will review before the next meeting and get back to Mr. Dubow with any suggestions. Mr. Brennan has a list of possible appointees and urges anyone who may be interested to send a resume to his office.

3. Noise Ordinance Request – Research Data

Mr. Brennan received research information from CCM regarding ordinances in other towns. Mr. Saxe will look through the information and come back with recommendations for next steps.

4. FY 13 Budget – Next Steps

David Lisowski, Assessor, gave a presentation on the recently completed Grand List for 2011, indicating a .61% increase. The previous year's Grand List increase was .46%, both being slow years based on the economy.

<u>CL&P</u>: On 3/30, Mr. Brennan, Mr. Thurkettle and Chief Lombardo will be meeting with CL&P officials to discuss the tree trimming program that has been increased from \$27MM per year to \$53.5MM.
