D. Discussion and Possible Action on Proposed Settlement in the case of Marissa Lowthert et al. v. Wilton Board of Education, et al., Docket No. FST-CV-15-6026938S
Ms. Vanderslice made the following comment on behalf of the three boards:
Current and past elected board members, current and past town employees, trial counsel Thomas Gerarde and members of his firm, Board of Education Counsel Jessica Richman Smith and Town Counsel Ira Bloom have collectively spent significant hours and effort over the last eight years related to this lawsuit.

We have consulted extensively with our lawyers either as a board or as represented by the appropriate board chairs. We deny liability, but understand the risks associated with any jury trial and Upon the recommendation of trial counsel, we have chosen to settle this lawsuit.

Two additional pieces of information, the Town's insurance carrier will be paying \$50,000 in addition to monies paid by the Town. This amount represents two times the coverage in the Town's Policy at the time of the claim. This agreement must be approved by the probate court. As such we are unable to provide further details or a copy of the settlement agreement until the agreement has been approved by the probate court.

Board of Selectmen

<u>BoE:</u> Ms. Low moved that the Board of Education, upon the recommendation of trial counsel, approve the settlement agreement in the case of Marissa Lowthert et al. v Wilton Board of Education et al., Docket No. FST-CV-15-6026938S and authorize the Superintendent Dr. Kevin Smith to execute the settlement agreement and approve up to \$225,000 of Board of Education reserves to be used for such settlement. Motion seconded by Ms. Deluca and carried unanimously.

BoF: Mr. Kaelin moved that upon the recommendation of trial counsel, approve the settlement agreement in the case of Marissa Lowthert et al. v Wilton Board of Education et al., Docket No. FST-CV-15-6026938S and support up to \$225,000 of Board of Selectmen reserve funds and up to \$225,000 of Board of Education reserve funds to be used for such settlement. Motion seconded by Mr. Koenigsberg and carried unanimously

BoS: Ms. Vanderslice moved that the Board of Selectmen, upon the recommendation of trial counsel, approve the settlement agreement in the case of Marissa Lowthert et al. v Wilton Board of Education et al., Docket No. FST-CV-15-6026938S and authorize the First Selectwoman to execute the settlement agreement and approve up to \$225,000 of Board of Selectmen reserve funds and up to \$225,000 of Board of Education reserve funds to be used for such settlement. Motion seconded by Ms. McFadden and carried unanimously

Ms. Vanderslice thanked all board members along with Superintendent Dr. Kevin Smith for their hard work on this matter and all attorneys for their hard work and valuable counsel.
