Mike O'Connell presented the March meeting minutes to the Commissioners for review and revisions. Receiving no change requests, the March 2017 minutes were accepted as distributed.

Trackside Budget

Ann Mitrone, liaison Commissioner to the Trackside Board, updated the Commissioners on the status of the Town budget for Trackside as a follow-up to the presentation by Mark Ketley at the March meeting. In light of the Board of Finance elimination of \$25,000 from the Trackside budget, Ann outlined the Trackside board's 5-year plan to reduce their funding request to the Town. The details of the plan will be presented to the Board of Selectman on April 17, 2017.

<u>Liaison Report – Wilton Youth Council (WYC)</u>

Genevieve Eason summarized the Wilton Women's Club Fashion Show fundraiser, which will directly benefit the long-term awareness and prevention programs of WYC focused on opioid abuse. Final fund raising numbers will be provided at the May 2017 meeting.

Directors Report

Colleen Fawcett, acting Department manager, summarized the March activities of the Department for the Commissioners. A short discussion ensued regarding the Food Pantry, specifically in response to a posting on Social Media. Judy Zucker summarized a presentation by the Wilton Assessor's office at the Senior Center on elderly tax relief.

2017-2018 Budget Review

Colleen informed the Commissioners the budget was accepted by the Board of Selectman and Board of Finance as previously reviewed.

New Director - Sarah Heath

Deb reviewed an email she shared with the Commisioners welcoming Sarah Heath to the Department of Social Services. He first day is April 17, 2017.

The Commissioners extended a unanimous Thank You to Colleen Fawcett for serving as Acting Department manager while the search was conducted.

Nominating Committee 2017-2018 Officers

Pam Kelley and Christine Tenore agreed to serve on a nominating committee for 2017-2018 officers of the Commission. They will present their recommendations for review by the Commissioners at the May 2017 meeting.
