WILTON CONSERVATION COMMISSION

Wednesday, June 1, 2022 – 7:00 P.M. ZOOM MEETING MINUTES

- **I. CALL TO ORDER:** Ms. Algon called the meeting to order at 7:03 p.m.
- II. NEW COMMISSIONER INTRODUCTION

Ms. Algon welcomed Sadiqua Azad and David Silvia formally to the Commission.

III. PLANNING & ZONING REFERRALS

A. SP#491, WILTON LAND CONSERVATION TRUST, 183 Ridgefield Road, construction of a barn with office and bathrooms

Mr. Silvia stated he attended the meeting for this Application and noted the Planning & Zoning Commission remarked on items such as the need for more parking spaces and the proposed new driveway due to the grade and drainage.

The Commission agreed there are no conservation-related comments.

B. SP#489, BRIDGE CROSSING, LLC, 586 Danbury Road, to allow for contractor's yard in General Business Zone

Ms. Algon noted this Application was withdrawn from the Planning & Zoning Commission and will not be discussed.

IV. INLAND WETLANDS REFERRAL

A. WET#2794(S) KULKE - 860 Ridgefield Road - "corrective action" to address unauthorized clearing and earthwork

Mr. Conklin reviewed the violation and mitigation plan to restore the wetland area that was cleared.

The Commission agreed there are no conservation-related comments.

V. ONGOING BUSINESS

- a. Walks & Talks Ms. Algon noted Walks & Talks are difficult to plan with COVID-19. Informative videos are being shared on social media in their place.
- b. Planning & Zoning Liaison Report Mr. Silvia attended both P&Z Meetings. He noted there were details missing from the 183 Ridgefield Road Application that were requested from the Land Trust.
- c. Status of Native Plants & Pollinator Pathway Proclamation/P&Z Landscape Regulations Ms. Algon provided background on this initiative and stated some new language is proposed for the Planning & Zoning Regulations. Mr. Simone confirmed the information was sent the to the Town Planner, Michael Wrinn.

VI. COMMUNICATIONS

a. Email from Lynne Vanderslice, First Selectwoman re: Pollinator Pathway Resolution for Wilton

Mr. Simone noted Lynne Vanderslice is amenable to a Proclamation rather than a Resolution, but some language needs to be changed. A Special Meeting will be scheduled for this discussion.

VII. NEW BUSINESS

a. **2022 Deer Management Plan** – Mr. Conklin displayed the 2022 Hunt Plan for approval. Mr. Conklin stated Wilton Land Conservation Trust had a request to keep Slaughter Field open to the Public for the duration of the hunt.

Mr. Simone MOVED to APPROVE the 2022 Hunt Plan, SECONDED by Ms. Azad and CARRIED 4-0-0 with all in favor.

- b. **Wilton Go Green Zero Waste Faire** June 5, 2022 Commissioners discussed the timing, set-up and staffing for the event at Miller Driscoll School.
- c. **Townwide Clean Up Day Summary** Mr. Conklin stated 100 people attended this successful event. He discussed new initiatives for 2023 including preregistration and T-shirts for all attendees in lieu of gift certificates.

a. Special Meeting Minutes - May 4, 2022

Mr. Silvia MOVED to APPROVE the Meeting Minutes of May 4, 2022, SECONDED by Mr. Simone and CARRIED 3-0-1 with Ms. Azad abstained, as she was not present.
