- 1. Peter Wrampe called the meeting to order at 7:01pm.
- 2. Agenda reviewed, with no motions to add topics.
- 3. **Approval of minutes** of January 15, 2019 regular meeting. First, Glenn Hemmerle; Second, Dave Heiden; minutes approved unanimously, with no abstentions but subject to the following corrections:
 - i. Page 10, Section 10a, Paragraph 2, Line 1: replace Robertson with Robbins
 - ii. Page 10, Section 10b, Paragraph 3, Line 2: replace Weston with Middletown

4. Discussion with First Selectwoman

Commission Procedural Matters

Of the two vacating seats, Jim Jarvie's seat is expected to be filled first, and Patrice Gillespie's is expected to be filled second (March 19 meeting will be Patrice's final meeting).

If an Executive Session is called, public members cannot be included unless there is a valid reason and they are invited as part of the motion. On a committee of nine (9), there cannot be more than six (6) members of one party. With that said, seats are not "owned" by one party or the other.

Sub-committees

Any Committee/Board can form sub-committees consisting of their own members. However, if a Committee/Board (e.g., WEC) plans to appoint a sub-committee member who does not hold a committee/board seat, then the sub-committee itself and all appointees must be proposed to and approved by the Board of Selectmen.

WEC made a motion in January to form a sub-committee for Sustainable CT so that it would not take up excessive time during of the monthly WEC meetings. Given that WEC wants a non-WEC member (Debra Thompson-Van) to be a member of the Sustainable CT Sub-committee, WEC must write up and propose a Charge to the Board of Selectmen for approval of the Sub-committee and all its members.

Solar Update:

Bonding for Wilton High School will be up for approval during the May Town meeting. Roof replacement will begin in June, and then solar installation will begin after that. The project must begin generating energy by October 1, 2019, or will need to file for an extension. Cider Mill and Middlebrook will also add solar, but roof sections need to be replaced first. Consider bidding the entire project (roof replacement + solar) at the same time. Regarding Comstock there is the potential of finishing of the unfinished space within the building to move some town departments (e.g. from town hall expansion) to Comstock. This requires roof space for HAVC systems. Until those plans are completed, we can't develop a plan for solar at Comstock.

There is potential for 70% of Town Buildings to be 70% renewable energy, but the full 70% would be solar; we will want to look at this from an energy diversification perspective.

5. Sustainable CT Project Update:

Kevin Gardiner reiterated that the Town needs 180 points (with at least 5 from each of the 9 categories) to achieve Sustainable CT Bronze Status. Of the topics identified as achievable, there are 210 – 960 points available; with a median of 585 points (well above the 180 points needed).

Category 2: Expect the Category lead by Conservation Commission and Park and Rec Commission for <u>Well-Stewarded Land and Natural Resources</u> to yield 70 points. First round of documentation will be taken from 2019 Final Version of POCD.

Category 4: Wilton is updating the POCD with Sustainability actions incorporated. We expect to qualify in 2 categories, worth 20 points each for a total of 40 points.

Category 6: Reduce Energy use across all municipal and school buildings. <u>Benchmark and Track Energy Use</u> by responding to the <u>SCT Portfolio Manager data request</u>. Expect to achieve 20 points by demonstrating a 20% reduction from baseline year. Note: this may be lower as the look back period post- dates many of Wilton's achievements.

Category 6: Renewal energy -Purchase or install clean energy sources to power municipal buildings and school buildings. Electricity produced by the on-site installation that goes through the buildings meter will be counted fully. Points will be awarded in 10 points intervals as a percentage of your energy use powered by renewable sources. **Submit:** A <u>completed calculator</u> 20-30 points expected.

Category 8: Healthy, Efficient and Diverse Housing will be taken from POCD and updated with current P&Z and town documents for 10 points

Category 9 requires a Sustainable CT Equity Toolkit to be document in its entirety for any new Sustainable CT action of your choice and is worth 10 points.
