1. **Call to Order:** Chairman Hampson called the meeting to order at 7:10 PM.
2. **Approval of Minutes** of February 23, 2012 Meeting : Rob Sanders moved and Richard Creeth seconded the motion to approve the Minutes. The Minutes were approved unanimously.
3. **Neighbor to Neighbor Mid-term Report :** Stacy Stone & Jessica Bergman
