1. Call to Order: Meeting called to order at 5:02 PM

- 4. Motion (Schwartz) to Approve the Promotion of John Edwards to Deputy Fire Marshal to start September 12, 2022, seconded (Hall) at 6:04 PM. Passed 3-0-0.
  - Commission thanked DFM Kevin Plank for his service which will conclude in early 2023.

## 5. Monthly Reports:

- a. <u>Fire Marshal</u>: FM Grosso presented report. Brief discussion on FM monthly report; Busy month for Marshals, was in schools to complete inspections prior to openings, and some fire investigations. Also started commencing school fire drills. Stated it will be a big help to have John Edwards in early to keep disruption in the office to a minimum and maintain continuity.
- b. <u>Deputy Chief</u>: Discussed written report. Busy with training, as well as new recruit training (4 weeks). Reviewed with Captain Elliott training calendar and had some outside driver training come in. EMS operations group has approved our training schedule for EMS for next 14 months.

  - b. Completed PPE annual inspections, fit testing ongoing. Commissioner Hall inquired as to lifespan of PPE 10 year service life (NFPA).
