**A. Call to Order:** Meeting called to order at 8:04 a.m.

**B. Approval of Minutes:** Upon motions duly made and seconded, the Commission voted unanimously to approve the minutes of the Commission meeting held on August 2, 2017.

- c. **Station 2 Renovation:** Commissioner Tartell updated the Commission on the status of the Station #2 Building Committee's efforts.

- d. **Budget and Overtime:** The Commission and First Selectman Vanderslice discussed the need for the Department to not exceed its overtime budget. Commissioner Weldon agreed to work directly with Deputy Chief Amatrudo on this issue.

- a. **Automatic Aid:** The Commission discussed the Fire Department's automatic mutual aid agreements with New Canaan, Weston and Georgetown. The Consensus of the Commission was to further discuss those agreements at the Commission's next meeting.
- b. **Standing Order 08-05 Call Backs:** The Commission discussed the Fire Department's Standing Order #08-05 which had an effective date of December 15, 2008 and a revised date of June 14, 2016 (a copy of the Standing Order is attached). The Standing Order provides that the Department's off-duty firefighters may self-dispatch to certain emergency calls. The consensus of the Commission was to review the Standing Order and to further discuss it at the Commission's next meeting.
