A. Call to Order: Commission Chairman Mecozzi called the meeting to order at 0800 hours.

- B. **Deputy Chief Vacation Carryover:** The Commission considered a request by Deputy Chief Amatrudo to carryover unused vacation time into fiscal year 2015. Chairman Mecozzi noted that the maximum amount of permitted carryover vacation time was 120 hours. On a **MOTION** duly made and seconded the Commission voted unanimously to allow Deputy Chief Amatrudo to carryover up to the maximum of 120 hours.
- C. Personnel Search Committee: Mr. Mecozzi as Chairman of the Fire Chief Personnel Search Committee provided a report of the Committee. He reported that after several months of work the Committee had concluded that it was appropriate to appoint an interim Fire Chief. As Chairman of the Wilton Fire Commission Chairman Mecozzi made the following motion: MOTION to appoint Ronald Kanterman Interim Fire Chief for a period commencing on June 1, 2014 and concluding on June 30, 2015 subject to the successful completion of each of the Town of Wilton's post-offer, pre-employment tests to include a physical examination, drug screen, and background investigation and the

execution of an agreement between Mr. Kanterman and the Town of Wilton setting forth the agreed terms and conditions of Mr. Kanterman's employment with the Town of Wilton with an effective start date of June 1, 2014 such agreement to be executed no later than June 3, 2014. Such **MOTION** was duly made and seconded and passed unanimously.

The Commission then considered the role of Wilton Emergency Management Director. On a **MOTION** duly made and seconded the Commission voted unanimously to recommend for appointment to the First Selectman Interim Fire Chief Ronald Kanterman as the Town of Wilton Emergency Management Director.

D. **Adjournment:** On a **MOTION** duly made and seconded, the Commission voted unanimously to adjourn at 0805 hours.
