FIRE HOUSE #2 BUILDING COMMITTEE REGULAR MEETING 11 November, 2016

CTO

Chairman Rich McCarty called the meeting to order at 7:35 p.m. In attendance were Chairman Rich McCarty, Committee Members Kevin Czarnecki, Phil Reeves, Ron Hitter and Ross Tartell. Also in attendance were Chris Burney, Facilities Director of the Town of Wilton, Fire Chief Ron Kanterman, Aaron Nachbar, and a member of the Wilton Community.

MINUTES

Mr. Czarnecki proposed an amendment to the 9/29 minutes. He proposed that the following statement be included in the minutes: While Station 2 is under renovation, we strongly recommend that Engine 2 remain in service and within the District. Mr Tartell seconded the motion to amend the 9/29 minutes. The motion carried unanimously.

Mr. McCarty made a motion to approve the minutes of the August 2, 2016 meeting. The motion was seconded by Mr. Tartell. Motion carried unanimously.

ADDITIONAL TIME FOR PUBLIC COMMENT

Mr. Burney noted that many committees in Wilton are adding time for public comment at both the beginning and end of the meeting. The committee thought it was a useful idea. Mr Czarnecki made a motion to allow public comment at the beginning of the meeting and at the end of the meeting. The motion was seconded by Mr. Tartell and passed unanimously.

REVIEW OF THE SOR STATUS

The committee noted that the Fire Commission and The Board of Selectman (BOS) have both approved the SOR.

TEST WELL STATUS

Mr. Burney will give Donna Merrill, head of the Wilton Land Trust, Aaron Nachbar's contact information so that she can coordinate with Arron Nachbar and the Station 2 Building Committee. Members of the committee will be invited to join with Mr. Nachbar and Ms. Merrill as they walk the land and determine a place to drill a test well.

Mr. Nachbar will mark the spot, drill the test well, and then test the well. The committee should have the results of the test well by early December.

PUBLIC COMMENT

A person who lives on Vista Road raised the issue of the town's very tight budget for 2017. He suggested that the committee have a communication plan. The local citizen offered to support the work of the renovation committee and noted that the local neighbors support the renovation effort.

Mr. Burney offered to add local news outlets to the committee distribution list in order to increase communication with the press and the community.

SETTING THE AGENDA FOR THE NEXT MEETING (11/22/2016)
