- E. **Barn Grant:** Commissioner Foltz reported that the Congregational Church has submitted a CT Trust For Historic Preservation Barn Grant for the stabilization of the red barn (The Comstock Barn). application work and stabilization work. Grant is due in the end of February and if awarded will give \$5,000 to fix supports and provide new roof. The grant requires a match of the same.
