I. Call to order: 7:35 pm

a. Attendance: Commissioners Sanders, Weatherly, Pojano and Bendremer present.b. Minutes: April 5 minutes after discussion Sanders moves to approve, Bendremer seconds. Vote to approve is unanimous.

June 3 minutes after discussion Sanders moves to approve, Bendremer seconds. Sanders, Weatherly, and Bendremer vote to approve. Pojano abstains.

II. Lover's Lane Bridge Replacement: Frank Smeriglio/Director of Public Works presented plans for the bridge and described the construction process. Commissioners expressed support for the selection of building materials.

III. **475 Danbury Road**: Allison Sanders reported on the demolition without a permit. The matter was pursued by the Building Department. The owner supplied a demolition permit, and the Building Dept imposed a fine of \$500. The matter is closed.

IV. **Certified Local Government**: The HDC applied for, and recently received, "Certified Local Government" status for the Town. This was a goal of both the current and previous POCDs. CLG status will allow the HDC to pursue grants from SHPO. After discussion, the consensus was to have commissioners suggest potential programs/projects for grants at a future meeting, prioritize them and initiate grant applications.

V. Local Historic District GIS Overlay Project: Lisa Pojano reported on the current status of the project; it is currently unscheduled as other projects have been given priority. Chair will seek more information.



PROJECT SITE LOCATION




EXISTING PLAN










North Approach (Looking South) South Approach (Looking North)




PROPOSED UPSTREAM BRIDGE ELEVATION





- Stone type to be "New England Mosaic" or approved equal






PICTURE SAMPLE OF "NEW ENGLAND MOSAIC"
