We received a notice from Eversource that they have to replace the street electric utility pole because it is in disrepair.

Servco still did not pass propane inspection.

Those 2 trenches remain open and the house is not inhabited.

After those can be closed I can begin to plant so there will be no disturbances and the trees will be viable for the 24 months as required to get the bond back.

It is scheduled for the next 3 weeks. I will keep you posted.

Hi Ms. Larkin and Mr. Conklin

My apologies but I have not been able to put the trees in.

I should have contacted sooner, but I have been consumed with trying to get my house back to a walkable state, never mind lived in.

The Propane company may have to relocate their line/equipment (first 2 to 3 attachments), as they did not get final approval at current house entry.

I am using Servco in Cannondale/Wilton. Not sure what the issue is, they said they would rectify.

Not sure what their hold-up is I have been awaiting a face to face meeting for over 30 days, as they are never there when I pass by. However I am told they are working every day.

The house has not been lived in, no plantings has happened. I tried on the opposite side and front, but their trucks ruined them, as Servco started their work in the wrong place (picture 1.)

The last couple of picture are the original trenches in March, when they closed the trenches back up they also opened those originally wrong.

If I can ask for a further extension, they are noting hopefully by July/August, it may be finished.

Hi Mr. Conklin – We do certainly appreciate the updated presentation of the pushed out date.

We certainly have since August/September been contacting along with my and other landscapers for the tree species native to CT.

We can provide the 20 or so nursery names contacted up and down the North to South and as far as Ohio and Indiana.

No one has the size of the 5-6 feet. Given the maintenance requirement needed, partial sun and the numbers required the height available is only 2 feet or potted.

A tree of partial sun is important given the replacement position and the current tree canopy.

We cannot go the full sun root as the replant success rate would be less than the 80% given it is not in a full sun space that is required.

We are certainly not waiting for them to come to us, we have a very active search and nursery e-mail alerts.

This farm distributor gave me a direct farm contact who noted the availability and we the distributor was able to make the sale.

The farm then noted to the distributor it would not be able to dig a week later. The charge was promptly refunded, no hassle.

Hence my request for the first extension given their promised delivery time of end October is now asked to change as it is not achievable.

We can switch out to the Thuja Green Giant if that is permissible. However that is not our first choice and would appreciate if we could wait.
