Dear Director Conklin:

As you know, our firm represents Wilton – 64 Danbury Road Owner LLC and Fuller Development, LLC (collectively, the “Applicants”) in the above-referenced application (the “Application”). It has come to our attention that Cardinal Engineering, the third-party reviewer of the Application, is unavailable for the April 11, 2024 meeting of the Inland Wetlands Commission of the Town of Wilton (the “Commission”). As such, the Applicants grant the Commission a second extension¹ of fourteen (14) days to allow the public hearing on the Application to continue to the Commission’s next regularly scheduled hybrid meeting on April 25, 2024, beginning at 7:30 pm.² Since the public hearing for the Application opened on February 22, 2024, the Applicants have granted a total of twenty-eight (28) days of extension to date. Per General Statutes §§ 22a-32 and 8-7d(a), the Applicants may only grant extensions totaling a period of sixty-five (65) days, leaving the Applicants with thirty-seven (37) additional days of extensions to grant.

The Applicants also request that the Agenda for the April 11th meeting clearly state that the public hearing regarding the Application will be continued to April 25, 2024, and that the April 25th meeting will take place at 7:30pm and may be attended via Zoom (with the link to attend virtually


¹ The first extension of fourteen (14) days was granted by way of my letter dated March 19, 2024, permitting the Commission to continue the public hearing from March 28, 2024, to April 11, 2024.

The Applicants further request that this same information is announced during the Commission's meeting on April 11th.
