RESOLVED:

The permit is subject to the attached General Conditions with the following General and normal Special Conditions:

- 1. Prior to the commencement of any on-site permit related activity, the applicant shall submit an estimate for the cost of the planting plan, the erosion and sedimentation control plan, and stormwater infiltration system for approval by this commission or its staff for the purpose of determining bond amounts.
- 2. Prior to the commencement of any on-site permit related activity, the applicant shall post a bond in a form and an amount acceptable to this commission and town counsel. The portion of the bond attributed to the planting plan shall be eligible for release at the end of the second full growing season after the planting plan is fully implemented. No portion of the bond is eligible for release until Special Condition #5 below is satisfied. In the event the applicant fails to properly implement and maintain the planting plan, the erosion and sedimentation control plan, stormwater infiltrators and rain gardens, the Town reserves the right to use the bonded funds to correct such deficiencies.

- 3. Prior to the commencement of any on-site permit related activity, the applicant shall submit photo documentation of the site. The photos shall be both wide angle and close up shots. They shall be labeled and cross referenced on a site plan.
- 4. Prior to the commencement of any on-site permit related activity, the applicant shall submit an information packet to the office of this commission for approval by staff. The packet shall contain information regarding the purpose and maintenance of the infiltrators, information regarding the presence of areas regulated by this commission, and lastly, information regarding environmentally friendly lawn care practices. Once approved, this packet shall be provided to the end user and evidence of their receipt shall be submitted to the office of the commission within one week of the property transfer.
- 5. Prior to the commencement of any on-site permit related activity, the applicant shall draft a "*Declaration to Maintain Drainage Facilities*" and submit it for review by Commission Staff and Town Counsel. Once approved by staff and Town Counsel the declaration shall be filed on the Wilton Land Records.
- 6. Prior to the commencement of any on-site permit related activity, the applicant shall coordinate any proposed tree removal within the Town Right-of-Way with the Tree Warden.
- 7. Prior to any clearing work for the driveway, storm drainage work alongside Nod Hill Road shall be in place to help reduce erosion in to the roadway during construction.
- 8. The applicant shall keep extra sediment and erosion controls on-site for emergency use in the event the primary controls fail during a major storm event. The extra controls shall remain on-site until the Commission staff determines the site is completely stabilized and construction is complete.
- 9. The applicant shall provide an as-built plan of the infiltration/stormwater management system for the site and a letter from the engineer of record attesting to conformance of the constructed system to the approved system.
- 10. The applicant shall cause to be prepared a foundation as-built plan that depicts the limit of lawn, boulder or other form of demarcation, wetlands, watercourses and their regulated areas, and rain gardens. The plan shall also include a note directing the reader to the office of the Inland Wetlands Commission for further information regarding WET#2663. This plan shall be in a form suitable for filing on the Wilton Land Records. The applicant shall file copy of the plan on the Wilton Land Records. The applicant shall submit two copies of the filed document to the office of the Commission. No portion of the bond in Special Condition #2 above may be released until this condition is fully satisfied.
- 11. The planting plan shall be fully installed within six months of receiving either a permanent or temporary Certificate of Occupancy.

RESOLUTION#0121-03WET

GENERAL CONDITIONS

IN THE ISSUANCE OF ALL WILTON INLAND WETLANDS COMMISSION PERMITS

- 1. The permittee shall notify the Director of Environmental Affairs 24 hours prior to the commencement of work and upon its completion.
- 2. If the authorized activity is not completed on or before 1/28/26 said activity shall cease and, if not

previously revoked or specifically extended, this permit shall be null and void.

- 3. No equipment or material including fill, construction materials, or debris, shall be deposited, placed, or stored in any wetland or watercourse on or off site unless specifically authorized by this permit.
- 4. All work and all regulated activities conducted pursuant to this authorization shall be consistent with the terms and conditions of this permit. Any structures, excavation, fill, obstructions, encroachments or regulated activities not specifically identified and authorized herein shall constitute a violation of this permit and may result in its modification, suspension, or revocation. Upon initiation of the activities authorized herein, the permittee thereby accepts and agrees to comply with the terms and conditions of this permit.
- 5. Prior to commencement of any construction, including road, accessways, drainage systems, and lots, each and every general contractor and subcontractor employed by the applicant or subsequent purchaser shall execute a document in the form annexed indicating that the contractor or subcontractor has fully familiarized itself with and understands the Wilton Inland Wetlands and Water Courses Regulations as they apply to its project, and with the terms of the permitted activity, including the general and special conditions which may pertain.
- 6. The permittee shall employ best management practices, consistent with the terms and conditions of this permit, to control storm water discharges, to prevent erosion and sedimentation and to otherwise prevent pollution of wetlands or watercourses. For information and technical assistance, contact the Director of Environmental Affairs. The permittee shall immediately inform the Commission of any problems involving wetlands or watercourses which develop during the course of, or which are caused by, the authorized work.
- 7. In evaluating this application, the Commission has relied on information provided by the applicant and, if such information subsequently proves to be false, deceptive, incomplete and/or inaccurate, this permit shall be modified, suspended or revoked.
- 8. Nothing in this permit shall obviate the requirements for the applicant to obtain any other assents, permits or licenses required by law or regulation by the Town of Wilton, State of Connecticut and the Government of the United States, including any approval required by the Connecticut Department of Environmental Protection and the U.S. Army Corps of Engineers. Obtaining such assents, permits or licenses is the sole responsibility of the applicant.
- 9. This permit is subject to and does not derogate any present or future property rights or other rights or powers of the Town of Wilton, conveys no property rights in real estate of material nor any exclusive privileges, and is further subject to any and all public and private rights and to any federal, state and local activity affected hereby.
- 10. This authorization is not transferable without the written consent of the Wilton Inland Wetlands Commission.
- 11. Where applicable, the oil tank shall be above ground or in the basement of the dwelling.
