LEGAL NOTICE - PUBLISH ONCE

The Wilton Inland Wetlands Commission took the following ACTION on November 10, 2022

GRANTED with conditions, Wetlands Application **WET#2831 – KOCH/MILCH** – proposed new septic system, reconfigure land, new spa, remove and replace retaining walls, remove steps, expand terrace, new gravel motor court and new stone dust path at 198 Mill Road, New Canaan, CT (Wilton Assessor's Map #136, Lot #4).

GRANTED with conditions, Wetlands Application **WET#2835 – ROBLES** – “corrective action” to address unauthorized removal of trees and placement of concrete pad, remove asphalt driveway and place gravel, install stone pilasters at the end of the drive at 114 Thunder Lake Road, Wilton, CT (Assessor's Map#26, Lot #2).

GRANTED with conditions, Wetlands Application **WET#2836 – ALLAM** – after-the-fact permit for replacement of a culvert underneath the driveway and associated earthwork at 271 Cannon Road, Wilton, CT (Assessor's Map #7, Lot #13).

GRANTED with conditions, Wetlands Application **WET#2839 – CROMWELL** – “corrective action” to address twelve trees removed without a permit at 23 Nod Hill Road, Wilton CT (Assessor's Map#91 Lot #4)

GRANTED with conditions, Wetlands Application **WET#2842 – MORELLO** – proposed removal of non-native invasive plants with a one-to-one replacement of native plants at 31 Carriage Road, Wilton CT (Assessor's Map#118 Lot #30)

GRANTED with conditions, Wetlands Application **WET#2843 – SMITH** – proposed installation of in-ground pool outside regulated area and patio 92 ft. from a wetland at 52 Grey Rocks Road, Wilton CT (Assessor's Map#94 Lot #27)

GRANTED with conditions, Wetlands Application **WET#2844 – CHRISTIANSON** – “after-the-fact” two A/C condensers 32 ft. from a wetland at 51 Cherry Lane, Wilton CT (Assessor's Map#43 Lot #25-1)
