A black tupelo, an old swamp maple (dangerous, dropped significant limbs and/or close to house). A hemlock on 100ft upland buffer boundary, too close to installation of pool (recent permit granted). Several invasives bushes (winged euonymous), not marked.

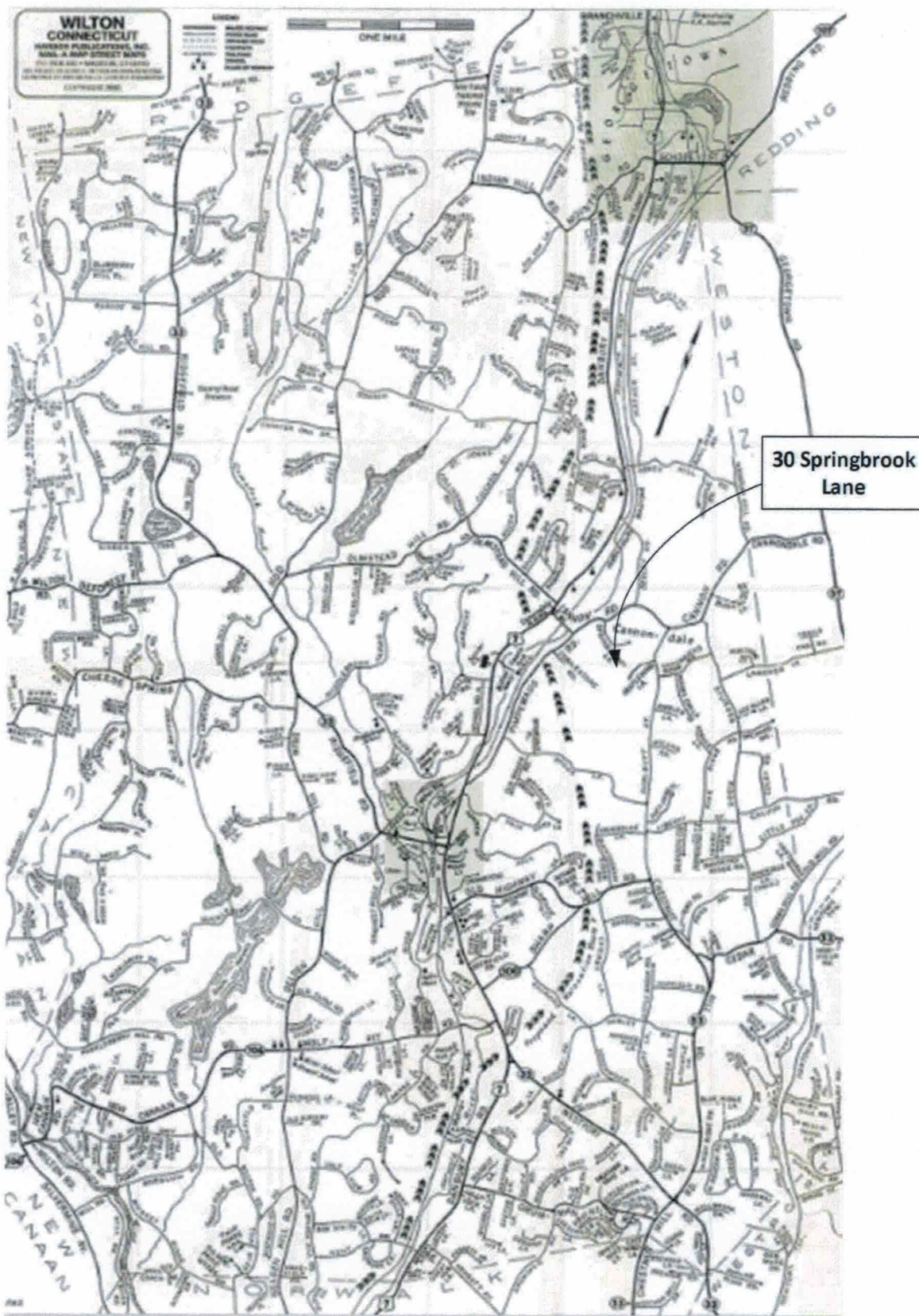
