# MEETING MINUTES ELECTRONIC ZOOM MEETING February 25, 2021

#### I. CALL TO ORDER

Mr. Lee called the meeting to order at 7:30 pm.

#### II. PUBLIC HEARING

**A.** WET#2654(S) BEHRENS – 220 Nod Hill Road – "corrective action" to address the unpermitted clearing of trees within a regulated area

Mr. Conklin confirmed the Corrective Action Application has not been received in its entirety and reminded the Commission this property is still under a Cease & Desist Order.

With no further questions or discussion, the Public Hearing was continued.

**B.** WET#2674(S) WALTERS-FRANCIQUE – 129 Skunk Lane – proposed addition, swimming pool, and associated improvements, with a B100a

Ms. Throckmorton described the property and the wetlands. She noted the pool site, the small addition over an existing deck, and the B100a. With many site constraints, there are no alternatives.

The Public Hearing was closed.

Mr. Fischer MOVED to APPROVE WET#2674 with normal Special Conditions, SECONDED by Ms. Avallone and CARRIED 4-0-0 with all in favor.

#### V. APPLICATIONS READY TO BE REVIEWED

**A.** WET#2675(I) AUGUSTINE – 27 Ground Pine Road – proposed new septic system within a regulated area

Mr. Rogers described the old septic system was not in working condition so they are replacing the leaching system and the tank while making some minor site improvements to the site outside the regulated area.

Ms. Avallone MOVED to APPROVE WET#2675 with normal special Conditions, SECONDED by Mr. Fischer and CARRIED 4-0-0 with all in favor.

**B.** WET#2676(I) CASSIDY – 368 Nod Hill Road – proposed additions and other site improvements within a regulated area

Mr. Mroz explained the project and noted hand-digging will take place to replace the foundation. Mr. Conklin noted he was familiar with the site and the plantings that exist are a model for others property owners to follow.

Mr. Fischer MOVED to APPROVE WET#2676 with normal special Conditions, SECONDED by Ms. Avallone and CARRIED 4-0-0 with all in favor.

**A.** WET#2679(S) ALICEA – 104 Old Mill Road – "emergency" septic repair within a regulated area

Ms. Avallone MOVED to ACCEPT WET#2679 and schedule for the next available meeting, SECONDED by Mr. Fischer CARRIED 4-0-0 with all in favor.

# **A. ATTANASIO** – **47 Mollbrook Drive** – request to extend deadline for Corrective Action Permit Application

Mr. Conklin noted the Property Owners hired Tracy Chalifoux to assist with the Application and they are requesting an extension of the deadline from March 10, 2021 to April 7, 2021 due to snow cover.

Mr. Fischer MOVED to GRANT an EXTENSION to April 7, 2021, SECONDED by Ms. Avallone and CARRIED 4-0-0 with all in favor.

# B. IKEGAME – 16 Rivergate Woods – unpermitted pond dredging

Mr. Conklin noted the deadline for the Corrective Action Application was missed. A follow-up letter was sent with a further deadline and that date has also lapsed. A Municipal Citation has been issued and the owners seem to be moving forward to avoid further fines and legal action.
