# MEETING MINUTES HYBRID MEETING May 12, 2022

#### I. CALL TO ORDER

Mr. Stow called the meeting to order at 7:30 pm.

#### II. SHOW CAUSE HEARING

**A. ALLAM – 271 Cannon Road** – unauthorized replacement of drainage pipe under the driveway and earthwork in a wetland

Mr. Conklin provided the background and timing of the violation. Mr. Allam explained the work he completed and noted his driveway was flooding due to a collapsed culvert. He stated his contractor replaced the 2 ft. culvert with a 3 ft. culvert in its place.

Mr. Lee MOVED to UPHOLD the Cease & Desist Order and require the Allams to submit a Significant Corrective Action Permit Application by noon on June 21, 2022, SECONDED by Ms. Sayegh and CARRIED 4-1-1 with Mr. Bigosinski opposed and Dr. Pinou abstained.

**A.** WET#2781(S) DAVIDSON/MUELLER – 425 Ridgefield Road – proposed construction of a single-family dwelling

Mr. Davidson noted a new plan was prepared. Mr. Quinn presented the new plan and Mr. Lee noted a typo on the plant list. A silt fence was added to impede surface water flow through the construction site.

Dr. Pinou asked Ms. Throckmorton about habitat and site visits to determine ponding and vernal pooling areas. Ms. Throckmorton confirmed no wetland dependent species would be present.

Mr. Conklin asked that the Hearing be held open to allow the Town Engineer time to review the responses from Peak Engineers.

Mr. Lee MOVED to HOLD OPEN the Public Hearing, SECONDED by Dr. Pinou and CARRIED 5-0-1 with Ms. Sayegh opposed.
