MEETING MINUTES HYBRID MEETING January 26, 2023

I. CALL TO ORDER

Mr. Stow called the meeting to order at 7:30pm.

II. SHOW CAUSE HEARINGS

A. VALENTIN – 573 Nod Hill Road – unauthorized removal of nine trees

Mr. Herter explained the violation and timeframe. No owner or agent appeared at the meeting.

Ms. Sayegh MOVED to UPHOLD the Cease & Desist and require the Owner to submit a "Corrective Action" Application by 12 noon on February 21, 2023, SECONDED by Mr. Simone and CARRIED 4-0-0.

B. KRUT – 134 Deforest Road – unauthorized removal of sixteen trees

Mr. Herter explained the violation and timeframe.

Mr. Krut stated the trees were dead and they were concerned about falling branches on the property, risking life and structures. He advised that he called the Town to ask for the procedure but never received a call back. Mr. Conklin responded that he was not contacted by the property owners at any time.

Ms. Sayegh MOVED to UPHOLD the Cease & Desist and require the Owners to submit a "Corrective Action" Application by 12 noon on February 21, 2023, SECONDED by Mr. Simone and CARRIED 4-0-0.

III. PUBLIC HEARING

A. WET#2845(S) STERNHEIM/GARDNER – 390 Ridgefield Road – proposed dam removal

Mr. Stow noted SNEW has requested more time to review the Application as a Third-Party Consultant has been hired for this purpose.

With no questions from the public, the Public Hearing was kept open for SNEW comments.
