# MEETING MINUTES ELECTRONIC ZOOM MEETING September 24, 2020

#### I. CALL TO ORDER

Ms. Craig called the meeting to order at 7:32 pm.

#### II. PUBLIC HEARINGS - None

#### IV. APPLICATIONS READY TO BE REVIEWED

**A.** WET#2646(I) KANNRY/DENEGA – 166 Millstone Road – proposed reset of existing terrace, relocate existing sheds, remove solid front walk and add stepping stone walk, add firepit and council ring, realign parking area, and future pool and terrace

Ms. King explained the enhancements the owners are proposing and the timeframe of construction. Commissioners requested that a planting plan be provided for approval at the next meeting on October 8, 2020.

**B.** WET#2643(I) LORIG – 269 Millstone Road – "corrective action" to address unpermitted filling in a regulated area

Nick Lee recused himself from this application.

Mr. Lorig, Ms. Sullivan, and Mr. Dinapoli reported that they are attempting to bring back the original grade by removing the unpermitted fill. Removal can be done by hand or by mechanical means with all soil and erosion controls in place.

The Commission asked that the Applicant appear at the next meeting with a revised plan

showing the wetlands demarcation over-layed with the Otto Theall wetland delineation.

C. WET#2652(I) GUEST/RICCA – 23 Coley Road – regrade portion of rear yard and construct retaining wall within a regulated area

Mr. Lee was re-seated.

Ms. Throckmorton described the project and the wetlands on site.

Ms. Avallone MOVED to APPROVE WET#2652, with normal Conditions, SECONDED by Ms. Mandel and CARRIED 7-0-0 with Ms. Craig in favor, Mr. Fischer in favor, Mr. Whitted, Mr. Lee in favor, Ms. Mandel in favor, Ms. Avallone in favor, and Mr. Stow in favor.

**D.** WET#2653(I) TOMAS – 6 Appletree Lane – proposed single-family residence and associated improvements within a regulated area

Mr. Allen explained the plan and the wetlands on the site. He stated there are no wetland impacts to the site with the proposed work.

Ms. Mandel MOVED to APPROVE WET#2653, with normal Conditions, SECONDED by Mr. Fischer and CARRIED 7-0-0 with Ms. Craig in favor, Mr. Fischer in favor, Mr. Whitted, Ms. Mandel, Ms. Avallone, Mr. Lee in favor, and Mr. Stow in favor.

B. WET#2517(I) CHUTE – 44 Graenest Ridge Road – permit variance request for removal

of required boulder demarcation and removal of one tree

Mr. Chute requested to forgo the boulder demarcation line as there is a natural tree line. He also asked that a tree be allowed to be removed.

Mr. Fischer MOVED to APPROVE the requested removal of one tree and enforce the boulder demarcation as required on the approved site plan, SECONDED by Mr. Stow and CARRIED 7-0-0 with Ms. Craig in favor, Mr. Lee in favor, Mr. Stow in favor, Ms. Mandel in favor, Mr. Fischer in favor, Ms. Avallone in favor, and Mr. Whitted in favor.
