I. CALL TO ORDER

A. WET#2616(S) MITCHELL – 146 Cedar Road – proposed filling of an abandoned pool

Mr. Anderson explained sequence of filling the abandoned pool. Commissioners asked questions to ensure the resource is protected during the activity.

B. WET#2617(S) FRIENDS OF NORWALK RIVER VALLEY TRAIL (NRVT) – Kent Road & Wolfpit Road – proposed approximately 4,200 ft. of stone dust trail, a gravel parking area, one culvert, and 152 ft. of boardwalks at Grist Mill Road/Old Belden Hill Road to Kent Road

Mr. DiCamillo reviewed the proposed route and alternatives. Mr. Fain answered Commissioner questions about the wetlands.
