MINUTES Wilton Parks & Recreation Commission March 8, 2017 Comstock Community Center 7:30 PM

I. Call to order: 7:35pm

II. Approval of Minutes of January 11, 2017 meeting

Motion to approve by Commissioner Kendra, seconded by Commissioner Connolly. Passed 3-0-1.

III. Budget Discussion with First Selectman Lynne Vanderslice

P&R programming budget is not self-sustaining as did not include key staff salary (director of programming position). Fees for programs going forward will be adjusted to cover staff costs.

We will also start thinking about future role of P&R alongside other groups like Wilton Continuing Education, Senior Services, and Wilton Library.
