- 3. Elevations (A-200) prepared by Crosskey dated March 16, 2020.
- 4. Elevations (A-201) prepared by Crosskey dated March 16, 2020.
- 5. Front Elevations with Blue Door prepared by Workforce Partners ("WP") dated March 16, 2020.
- 6. Front Elevations with Grey Door prepared by WP dated March 16, 2020.

The plans were revised as follows:

- 1. The height and scale of the entry canopies were increased and gables were added.
- 2. The gable on gable on the front facade was eliminated and large gables were provided.
- 3. The accent shake siding was eliminated.
- 4. A large center dormer was added.

- 5. A brick base in lieu of stone was provided.
- 6. The building color was changed to white.
- 7. The door color was changed. Two different elevations are attached, one with blue doors and one with grey doors. Blue doors are preferred by Three Hubbard as that matches its brand colors. The doors will be gray if that is the color preferred by the Board.
