Rebuild Existing Retaining Wall & Associated Site Grading

## **Dear Commission Members:**

This firm has been retained by Tania and Yuri Vizer (collectively the "Vizers") to represent their interests in the above referenced application pending before the Wilton Planning and Zoning Commission. We write on behalf of the Vizers in support of removing and/or rebuilding the existing retaining wall.

The Vizers are the owners of real property commonly known as 46 Saunders Drive, Wilton, Connecticut, 06897 ("Vizers' Property"). The southern property line of the Vizers' Property abuts the northern Property line of 53 Sugarloaf Road, Wilton, Connecticut 06897 ("Lupinskis' Property"). Prior to the Vizers' purchase of the Vizers' Property, the Lupinskis constructed a boulder retaining wall without the proper permits and which partially encroaches onto the Vizers' Property. The construction and continued existence of this poorly built retaining wall has caused significant damage to the Vizers' Property. The condition of the current retaining wall is unstable and potentially hazardous. The Vizers are fearful of the continued existence and the potential dangers that could occur if the wall is not removed or repaired as soon as practical. These dangers are particularly acute given the steep grade of the hill between the Vizers Property and the Lupinskis Property.

Based on the foregoing, the Vizers' urge the Commission to consider the application submitted by the Lupinskis to rebuild the exiting retaining wall and perform the proper site grading at its earliest possible meeting date and to take into account the potential ramifications to the Vizers' Property caused by any delay in remedying this problem.
