Dear Mr. Chairman and Members of the Commission:

We are forwarding the following information to supplement the referenced application:

1. The height of the light fixtures along the proposed driveway and reconfigured surface parking lot will be eighteen (18') feet above the ground. The light fixtures are Gardco fixtures, which are described in further detail on the Site Lighting Photometric Calculation, titled "SL-1," prepared by Apex Lighting Solutions, dated June 7, 2022. On the aforementioned plan, at the location of each proposed fixture you may observe that the fixtures are labeled either "SA2" or "SA5" with "MH: 18" below the fixture model. The phrase "MH: 18" indicates that the mounting height of the fixtures, which will either be SA2 or SA5 Gardco fixtures, will be 18' above ground. The aforementioned plan was submitted as part of the previous supplemental submission dated June 8, 2022.
2. Material Examples Drawings, titled "M-100," prepared by Tighe & Bond, dated April 12, 2022, which illustrates the retaining wall options that were previously submitted to the Architectural Review Board in a letter from Gregory and Adams dated May 2, 2022
