Call To Order

Commission Chairman Chris Giovino called the meeting to order at 4:00 p.m. In attendance were Commissioners Adrienne Reedy and Thomas Sinchak, Chief Thomas Conlan, Deputy Chief Robert Cipolla and Lieutenant Gregg Phillipson.

Public Comment

A motion was made to scramble the meeting agenda to address a request for the installation of a 3 way stop sign at the intersection of Grumman Hill Rd and Washington Post Dr. Pia Scaglione (97 Washington Post Drive) and Carol Ball (80 Washington Post Drive) spoke in support of the proposal and described the various issues they have experienced. DC Cipolla reviewed the criteria that would typically be required in order to warrant a 3 way stop sign (e.g., volume of traffic) and reported that based on our study the necessary conditions did not exist in this case. Further, that there have been no accidents reported at this intersection. After discussion, Commissioner Sinchak moved that we accept the recommendations of the traffic study prepared by the Department. Commissioner Reedy seconded and the motion passed unanimously.
