Call To Order

Commissioner Sinchak made a motion to promote Lieutenant Gregg Phillipson to the position of Captain, at a time to be decided by Chief Conlan consistent with the needs of the department. Commissioner Reedy seconded the motion and it carried unanimously.

Commissioner Giovino made a motion to promote Police Officer Jonathan Patry to the position of Sergeant, at a time to be decided by Chief Conlan consistent with the needs of the department. Commissioner Reedy seconded the motion and it carried unanimously.

The Commission wanted to thank all candidates and congratulate our newest promotions.
