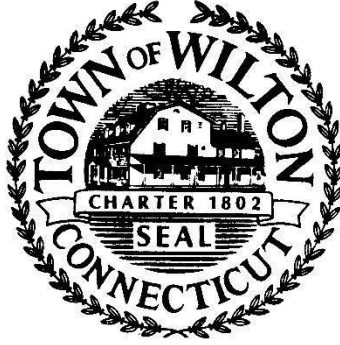

Call To Order

Acting Commission Chairman Adrienne Reedy called the meeting to order at 5:00 p.m. In attendance were Commissioner Thomas Sinchak, Chief Thomas Conlan, Deputy Chief Robert Cipolla and Captain Gregg Phillipson.

Reading and Approval of Minutes from the August 14, 2023 Regular Meeting
