PRESENTATION OF ARCHITECTURAL FIRMS

The committee heard presentations as a result of a Request for Qualifications for Architectural Services by two firms tonight:

- 1.) Kaestle Boos Associates, Inc. of New Britain, Connecticut and
- 2.) Lothrop Associates LLP Architects of Hartford, Connecticut

Note- Co Chairperson Waters indicated that, in his job as a practicing attorney, he has worked with one of the consultants referenced by one of the firms. He indicated that this presents no conflict, and that it will not impair his ability fairly judge the firms.

After all the presentations and much discussion, Mr. Johnson made a motion to recommend Tecton Architects as the preferred firm and that Kaestle Boos as second choice for the purpose of presenting conceptual design for a fee not to exceed fifty thousand dollars (\$50,000). Mr. Suchy seconded the motion. The motion passed 6-0 with Mr. Fordsman not voting.

The recommendation will be presented to the Board of Selectmen at their next meeting.
