Dear Ms. Ikegame,

At the November 12, 2020 meeting of the Inland Wetlands Commission, the Commission upheld the Cease and Desist Order that was placed on your property for the unauthorized work that was conducted without a wetland permit. On November 13, 2020, the Commission sent you a follow-up letter to notify you of the action and the requirement that you must submit a complete Corrective Action Wetlands Application by Wednesday, December 9, 2020. At this point the deadline has not been met as only a portion of the required information has been submitted. Below you will find a list of the required documents that are still missing and a list of what we have received to date.

Missing and still required documents include the following items listed on page 2 of the Application Form:

1. Fee for Disturbed Land @ \$400/1,000 sq. ft.
2. Site Plan showing existing and proposed features

7. Names & Addresses of Adjoiners
8. Soils Report by a CT Registered Soil Scientist
9. Biological Evaluation
10. Description of Fill Characteristics
11. Watershed Map
12. Envelopes to Neighbors and Fee for Mailing @ \$2 per envelope
13. 11 copies of all above information

**Violation:** Failure to comply with Directives of the Commission to Submit a complete Corrective Action Application

**Wetland Regulation Violated:** Section 6.3

**REASON:** You are hereby cited for violation of the Inland Wetland and Watercourse Regulations of the Town of Wilton for failure to comply with the directive to submit a complete Corrective Action Permit Application by December 9, 2020. After your failure to submit the Application on December 9, 2020, a letter was mailed to you with a new deadline of January 28, 2021. Since you have failed to meet this second deadline a Municipal Citation and Fine is being imposed. As indicated in the Wilton Ordinance Establishing Citation Procedures and Fines for Violations of the Inland Wetland and Watercourse Regulations ("the Ordinance"), and pursuant to Section 22a-42g of the Connecticut General Statutes, as amended, and in addition to the remedies provided in Section 22a-44 thereof, your violation has caused a fine to be levied against you.

You have thirty (30) days to make full payment by mail to the Town of Wilton, Inland Wetland Office, Town Hall Annex, 238 Danbury Road, Wilton, CT 06897. You can also deliver the payment in person using the drop box in the Town Hall Annex vestibule. Checks are to be made payable to the "Town of Wilton." Please note the Citation number on your check.

You have the right to contest your liability before the Citation Hearing Officer as provided by Section 4 of the Ordinance. Should you fail to pay the fine required by this citation within thirty (30) days, and should you choose not to request a hearing, the Hearing Officer shall thereupon enter judgment and assess the fine(s) as stated by citation(s). Failure to pay the assessment of any fine(s) made by the Citation Hearing Officer or failure to appeal his/her decision to the Superior Court within thirty (30) days of notice of his/her decision can result in a Superior Court judgment as provided by Connecticut General Statutes Section 7-152c.
