- VIII. BACKGROUND INFORMATION

*Extract of email from Joshua Cole, BOS, regarding Tree Committee's assignment:

...at our September 8th Board of Selectmen meeting we discussed the four priorities for the Town for the remainder of this year.

One of the priorities is improved resiliency following weather events and improved public utility services.

We have identified the Tree Committee as one of the town's committees which we think can help implement some changes to accomplish our goal of improved resiliency.

Among the items we would like the Tree Committee to look into are:

1. Proposing an ordinance restricting tree location and height along the road and near wires (Right Tree, Right Place Standards)

2. Proposing zoning changes to reflect the ordinance

3. Implementing/accelerating a Town Tree Removal Plan and increased funding for tree removal.
