- Q: Is financing in place?
- A: Yes, financing is in place for this project.
- Q: Are there CHRO requirements?
- A: There are no CHRO requirements for this project.
- Q: The drawings call to salvage the flagpole; specs call for new. Clarify
- A: The flagpole should be salvaged and reinstalled per the drawings. The specification section will be modified.
- Q: What is the anticipated start date?
- A: The owner has 90 days to award the contract per the instructions to bidders. However, the intent is that the process takes roughly 30 days with a mid-July start to construction.
- Q: Specification section 071900 Water Repellants is outlined in the Project Specification's Table of Contents; however, the specification section is not included in the specification documents. Please provide if required.
- A: This section is not utilized and can be removed from the Table of Contents
- Q: 054000 COLD FORMED METAL FRAMING is listed in the Table of Contents but could not be found in the bidding documents, please provide.
- A: This section is not utilized and can be removed from the Table of Contents
- Q: 095813 MONOLITHIC ACOUSTICAL CEILING SYSTEM is listed in the Table of Contents but could not be found in the bidding documents, please provide.
- A: This section is not utilized and can be removed from the Table of Contents
- Q: Spec Section 101100 Visual Display Surfaces: Type WC-2A Wall covering is not shown on the drawings. Please provide locations and elevation drawings for WC-2A Wall Covering.
- A: AWC-2 has been removed from the finish schedule. WC-2a has been renamed to WC-3 for clarity and is shown on elevation A7.21/K12 and on the First Floor Finish Plan.

Q: There is a conflict between Spec Sections 105113 Metal Lockers and Spec Section 105113.13 Specialty Lockers. Both specs sections have Locker Type L-3, the size shown on the drawings are not the same size that is listed under Spec Section 105113.13. Please advise which spec section these lockers pertain to and provide the correct locker size.

A: Metal lockers located in Dispatch have been designated as L-9 and have been removed from the specialty locker section of the specifications

Q: Spec Section 105113.13 -Specialty Lockers; There are numerous discrepancies between the specification (Spec Section 105113.13) and project drawings Q2.01 First Floor Equipment Plan and Q2.02 First Floor Equipment Plan. These discrepancies include sizes in some cases that do not match. Please review this spec and clarify sizes and quantities of L3-L4-L5-L7-L8, under specification section 2.03 - Evidence Lockers and 2.04 Weapons Evidence Lockers. Please review this spec and clarify sizes of L3-L4-L5-L7-L8.

A: Specifications should be utilized for all specialty locker sizes and configurations. The provided equipment plans are for coordination purposes only, but have been updated to better coordinate with the specifications.

Q: Several Demolition Subcontractors requested to walk-through and review the current Police Station earmarked for demolition. Please advise if a date and time can be provided for this request.

A: An additional non-mandatory pre-bid conference will take place on Tuesday June 13, 2023 to tour the existing Police Department.

Q: As discussed at the Pre-Bid Conference, several general contractors suggested changing the current bid date of Monday, May 22, 2023, at 2:00 pm, to a mid-week bid receipt date. We suggest Wednesday, June 28th at 2:00 pm. This would give the bidding general contractors two (2) weeks after receipt of the final addendum of Thursday, June 14, 2023, for review and final preparations for the bid.

A: The bid receipt date has been revised to 2:00 pm, Thursday, June 22, 2023 (local time).

Q: Under bid form, the bid bond stated in words is "ten percent" but in figure says "5%", please clarify the bid bond percentage.

A: Bid bond is to be 5%. The language has been modified to match the figure.

Q: Is Building permit fees waived or by the contractor?

A: Building permit fees are waived for this project.

- Q: Construction calendar days were provided in the specs. When is the construction start or finish dates?
- A: The owner has 90 days to award the contract per the instructions to bidders. However, the intent is that the process takes roughly 30 days with a mid-July start to construction. The dates of substantial completion and final completion shall be extrapolated from the information provided in the contract documents.

Q: What is the funding source for this project? Is there CHRO (SBE/MBE percentage) required? Please provide if there is any.

A: The project is full funded at this time. There are no CHRO requirements.

- Q: Dwg A9.10 Door Schedule indicates OH-2 as OH Sectional Doors. Dwg S3.00 detail 3 notes Coiling Door. Please confirm the OH-2 Doors should comply with Specification Section 08 36 13.
- A: OH-2 are sectional doors and should comply with specification section 08 36 13 SECTIONAL DOORS.
- Q: H6 & H9 on A7.12. It shows epoxy resin tops. The finish schedule doesn't call out for resin. Please clarify.
- A: Epoxy resin counter tops are covered in specification section 06 40 23 INTERIOR ARCHITECTURAL WOODWORK and designated as EPR-1. EPR-1 has been added to the finish schedule and referenced in elevations and details.
- Q: Details H6, H9 & K6/A7.12 all show an epoxy resin countertop. The surfaces schedule on I0.10 does not mention an epoxy countertop. Please clarify.
- A: See response above. EPR-1 designation has been added to the finish schedule and to referenced details on A7.12.
