- A. Call to Order
 - Ms. Vanderslice called the Trustees of the Retirement Plan for the Employees of the Town Committee meeting to order at 8:00PM
- B. Approval of Minutes May 7, 2018 Motion made by Ms. Bufano, seconded by Ms. McFadden and carried 3-0 with Mr. Clune, Ms. Low, Mr. Cole and Mr. Kalamarides abstaining as they were not present for the meeting.
- C. Presentation Investment Committee Paul VonSteenburg

 Jeff Rutishauser, Vice Chair of the Wilton Employees Retirement Plan Investment

 Committee gave a brief history of the Committee and introduced Paul VonSteenburg

 who reviewed the subjects listed below:
 - a. Investment Performance Overview
 - b. Investment Policy Recommendation
 - c. Periodic Review of Investment Advisor

After review, Mr. VonSteenburg noted that the Committee is recommending a change in the investment policy, see attached identified as Portfolio C. The Committee is also asking the Trustees to also approve a review of the Consultant.

D. Discussion of/and Possible Action on Investment Committee Recommendation(s) Mr. Clune recused himself from the voting process. Ms. Vanderslice asked for a motion to approve the recommended changes by the Wilton Employees Retirement Plan Investment Committee to the portfolio. Motion moved by Mr. Cole, seconded by Ms. McFadden and carried 6-0-1 with Mr. Clune abstaining.

Ms. Vanderslice asked for a motion to empower the Wilton Employees Retirement Plan Investment Committee to move forward with review of the current Consultant and bring forth recommendation to the Trustees. Motion moved by Ms. McFadden, seconded by Ms. Bufano and carried 6-0-1 with Mr. Clune abstaining.
