Executive order 9R issued by the Governor requires that municipalities reinstate the July 2020 tax relief programs for the upcoming January 2021 installment. In recognition of this order and of the financial hardships brought on by the global COVID-19 pandemic, the Town of Wilton is offering all qualified taxpayers the opportunity to delay payment of real estate, property and utility taxes, charges and assessments for 90 days.

The tax deferment program is open to all qualified residents, non-profits and businesses, including landlords. To qualify, taxpayers must attest that their income has decreased by at least 20% due to COVID-19 and since April have been furloughed without pay, had hours reduced or been unemployed.

Business and non-profit taxpayers must have a 30% decrease in expected revenue in the October 2020 to January 2021 period versus the October 2019 to January 2020 period. There are special provisions related to landlords.

## **Important Items of Note**

- 1. You must file your application, with supporting documentation, by January 27<sup>th</sup> for bills due February 1<sup>st</sup>, 2021. Please read the instructions below before completing the application.
- 2. Any bill not paid by 90 days from the due date will be subject to interest of 1 ½% per month.
- 3. The Town of Wilton accepts partial payments on all accounts.

- NOTE: ESCROWED REAL ESTATE ACCOUNTS ARE NOT ELIGIBLE FOR TAX DEFERRAL PER GOVERNOR'S EXECUTIVE ORDER.

- 3. Check the box that states you have suffered at least a 20% income loss due to COVID-19.
- 4. Provide proof of income loss since April 1, 2020 reduced hours, furlough, or unemployment determination statement.
- 5. Check the box stating proof of ownership and provide driver's license, utility bill or other proof.
- 6. Sign and date page 2 of the application.
