- 1. Call to order Kate called the meeting to order at 5:05 pm.

- 3. Tree Warden Report
 Lars submitted the Tree Warden's Report for January and February.
 Following a letter submitted for tree removal on Cobbs Mill Road,
 discussion continued on creating guidelines for tree removals along town
 roads. Lars volunteered to begin a list of bullets points to be considered
 for those guidelines.

4. Ongoing Business

- A. Center Tree Plan Status
 - Updated Wilton Center Tree Map: Mike Conkin will update map when information is available to him. We may have to update current maps for Arbor Day Celebration as a backup.
 - Bench Installations:
 Two benches at Stop & Shop now tentatively scheduled for the spring. Installation date depends on DPW schedule.
 - Updating Tree Inventory with Numbers and Tree Tags:
 Tags 1-9 were successfully installed last week with stainless steel screws. The committee will purchase additional screws and this will now move forward.
 - Assignment Areas for Inspection and maintenance of Wilton Center:
 Wilton Center Areas assignments were distributed at the meeting and will be followed up with an email.
 - New Tree Donations
 Three new trees locations and types have been determined. A Nyssa will be planted in the island adjacent to the Webster Bank kiosk, and one new Amerlancheris will be placed west of the Nyssa closer to the post office. VanAlstyne Tree will be replaced (Amelanchier). Kate will check with Liz Larkin on ordering bricks.
- B. Arbor Day (Friday) April 24, 2015. Celebration is tentatively scheduled for the afternoon in the Town Green, details to follow. Kate will draft press release within the next

week. At least one of the three trees to be planted this spring will be planted during this celebration.
