I. CALL TO ORDER

 - 2. N. Lee reported he has gotten no response from B. Quincy's son, and J. Algon indicated the Women's Club responded that Barbara was not an active member. J. Algon will check with the League of Woman Voters about their making a donation for the tree; W. Meehan will ask Kiwanis for a donation.
 - 3. The Committee's preference is to plant a shade tree at the corner of Old Hubbard and Old Ridgefireld Roads;

- ii. Judy Jones will check with the Library about planting a tree on that site in memory of her husband.
- b. Updating the Tree Inventory: no activity

- d. <u>Garden Club Plantings:</u> S. Knutson, President of the Wilton Garden Club, provided K. Throckmorton a list of the 10 gardens that are under the WGC's care to use in future tree planting location decisions.
