 - Summer Concert Series with P&R Vivian Lee-Shiue and Tracy Serpa provided a brief update on the upcoming concert series, the first of which will be at Schenck's Island the following Sunday (16th). Some notable items:

- College Creamery will be at Schenck's on the 16th and 23rd.
- Working with some local restaurants to provide "dinner specials" in town for the two concerts at Schenck's Island.
- For the two Merwin Meadows events, Tracy Serpa is working on getting food trucks.
- All updates will be posted to social media so that the public is aware of any food options.
- Marketing Working Group Update
 - Video video is largely done rough cut will be completed end of July/early August and final will be done by early/mid-August. The commission unanimously agreed that it didn't make sense to do a soft launch in August, and opted to wait for a single launch in September after Labor Day. There will be a special working group meeting called in August to review the "rough cut" to allow for any feedback to the video editing company.
 - Brochure the marketing group decided not to go forward with the release of the brochure during week of July 4th due to final edits and layout being done. Brochure is currently in final edit, after which time, one more pass will be done to review for grammar and spelling. Once complete, the brochure will be launched immediately.
- Digital Strategy Brad Unger updated the commission on the decision of the working group to scale back the contract to just 6 months due to the upcoming overhaul of the town's websites. Brad and/or the working group will need to present the contract for approval at the BOS meeting in August.
